Funding Resolution

The board passed a resolution for the Chief Executive to apply to NZCT for funding assistance towards wages for Development Officer, Events Manager, and Coaching Manager for the amount of \$120,000 and shuttles for school competitions and programs \$10,000.

General Business: BNZ Update -

 Discussed 2 scenarios regarding affiliation fees and assistance to tournaments

The Board has agreed for BNH to pay the full amount to BNZ for the affiliation fees and to send an invoice of 10k per year for the assistance to tournaments.

BNZ letter reply discussed - will ask Chris to draft a letter to send to BNZ.

Facilities:

Bond Crescent

- Final inspection on Wednesday 3 to 7 days to push go
- Lights been lengthened and tilted to an an angle to get rid of shadows better viewing upstairs due to lights moved higher
- Coffee machine had some issues.
- Court seats all delivered all in wheels and so much lighter to move around

Active BC

- building and resource consent issued
- 3 to 4 weeks to complete the Active BC facility at Corinthian Drive

ATP Update:

- Building consent revalued
- In a meeting with other sports, there was a motion to rename TCT to Harbour Sports Hub and the proposal for 5 person to represent the board, three from the 3 sports plus 2 independent people
- Three sports organisation to accept that they share the cost of any shortfall and cost of gaining building consent
- BNH board to decide if BNH will take the 80k shortfall and renaming of the hub, structure and name change

It was moved that BNH has agreed to pay the shortfall and confirmed they are happy with the name Harbour Sports Hub and the 5 people structure.

- A discussion on insurance premium whether to pay 55k for flooding for the 100k excess or the 45k for 250k excess as excess pay
 - Vero covers all other insurance
- Will ask for an option to pay monthly rather than one big amount just to help with the cashflow

It was moved that the board has agreed for BNH to pay 55k for the 100k insurance.

Performance Committee

- Glenn asked the committee to have a chat with Fanny and the coaches - need to educate the players and start them young
- Chris Blair, John Moody happy to be involved

Westlake Boys have contacted us that they have included badminton to their academy and will send selected students to train with us 2 or 3x a week.
